ALERT: People registering to compete in Cleveland County Agricultural Fair's Competitions **MUST** read and abide by the rules in the [Fairbook](#). In reviewing entries that have already been submitted as of September 7, 2018, either online, by mail, or in person, we are finding entries in some classes that do not comply with the Fair's rules. While entries which do meet the rules of the Fair will remain in the books, we must strike those entries that do not comply. We highly recommend that you review the rules and the entries that you have already submitted, and if you need to make any changes to your entries, send in an entry form (page 109 of the [Fairbook](#)) with your changes. If you have any questions, you may contact the livestock entry administrator at **704-487-0651**. Note that the highest concentration of errors is in the **Open Dairy Goat Show (BS) group class competitions**.

DEADLINE FOR LIVESTOCK [ONLINE ENTRIES](#) IS SEPTEMBER 12, 2018. You will not be allowed to enter any livestock category online after this date.

A one-time \$2.00 convenience fee will be charged for each individual who registers on this site. Once you register on the site, you may log in as many times as you need to make additional entries without being charged the convenience fee again. This fee will be included on your receipt upon your initial checkout. **IF YOU DO NOT WISH TO PAY THIS \$2.00, DO NOT CREATE AN ONLINE ACCOUNT.**

At this time, only entries for the livestock competitions and the Horse, Pony and Donkey Shows can be made online.

A copy of your invoice and payment of your fees should be mailed to Cleveland County Fair, 1751 E. Marion Street, Shelby, NC 28152. All fees for online registration should be received by the Cleveland County Fair on or before SEPTEMBER 15, 2018. If payments are not received by that date, online entries will not be considered complete and will be voided from the system. No exceptions will be made. If you need to pay by debit or credit card, you may call the Fair office at 704-487-0651 between

Note that registration of your entries is not considered complete until Cleveland County Agricultural Fair receives your payment. Entries are accepted on a first-come, first-serve basis and are limited to pen/tie space. If spaces are filled before we receive your payment, your entries may be disallowed in our competition(s).

If an online registrant has ANY fees due which have not been paid prior to the date for accepting entries, that registrant will not be eligible to receive fair passes, tickets, premiums, or prizes in any department.

LIVESTOCK: The entry fee for livestock is based upon each head entered, not each class entered. All entries in livestock group classes must be registered in individual classes. If you have problems registering in a specific category, please contact the fair office with specific information on the problem.
